### 16.3 Plotting Using $\mathrm{T}_{\mathrm{E}} \mathrm{X}$

## A. Purpose

These subprograms produce plots for documents prepared using the $\mathrm{T}_{\mathrm{E}} \mathrm{X}$ or $\mathrm{EA}_{\mathrm{E}} \mathrm{X}$ languages.

## B. Usage

To produce a plot using $\mathrm{TEX}_{\mathrm{E}}$ or AT TE , one constructs a program that uses SPLOT. SPLOT writes a file of $\mathrm{T}_{\mathrm{E}} \mathrm{X}$ or $\mathrm{EAT}_{\mathrm{E}} \mathrm{X}$ commands. The file is then incorporated into a $\mathrm{T}_{\mathrm{E}} \mathrm{X}$ or $\mathrm{EA}_{\mathrm{E}} \mathrm{X}$ document, which is then processed by a $\mathrm{T}_{\mathrm{E}} \mathrm{X}$ or $\mathrm{A}_{\mathrm{E}} \mathrm{EX}$ processor. Detailed instructions are given in Section B. 5 below.

## B. 1 Program Prototype, Single Precision INTEGER NX

REAL XSIZE, YSIZE, $\mathbf{X}(\geq \mathrm{NX}), \mathbf{Y}(\geq \mathrm{NX})$, OPT(see below)
CHARACTER COPT(see below)
Assign values to NX, XSIZE, YSIZE, X, Y, OPT and COPT, and use the following subroutine reference.

CALL SPLOT (XSIZE, YSIZE, X, NX, Y, OPT, COPT)

At this point, $\mathrm{T}_{\mathrm{E}} \mathrm{X}$ or $\mathrm{L}^{\mathrm{A}} \mathrm{T}_{\mathrm{E}} \mathrm{X}$ commands to produce the plot are in the file splot.tex (unless another file name is selected by options).

## B. 2 Argument Definitions

XSIZE [in] Physical horizontal size of the drawing area for the plot. Default units are inches.
YSIZE [in] Physical vertical size of the drawing area for the plot. Default units are inches. The nominal drawing area for the plot is a region of size XSIZE $\times$ YSIZE. The origin of the physical coordinate system is at the lower left corner, and all border lines are on the boundary of this region. Physical coordinates outside this area may be specified. The actual area of the image is increased by outward-pointing "tick" marks (see option5in Section B.3), "tick" labels (see
options 4 and 5 in Section B.3) or annotations placed outside the drawing area (see option 14 in Section B.3.

Many of the options refer to user coordinates that are specified in the same units as the points that are plotted. Different user coordinates may be used in a plot, see option 7 in Section B. 3 .
$\mathbf{X}$ [in] Array of NX abscissas.
NX [in] Number of abscissas in X and ordinates in Y.
Y [in] Array of NX ordinates. See also option 2 in Section B. 3 .
OPT [inout] $\operatorname{OPT}(1)$ is status output. Nonzero values indicate a problem for which an error message is printed. Possibilities are listed in the comments of subroutine SPLOTE in the file splot.f or splot.for. Unless one has taken special action by calling MESS, see Chapter 19.3, all except for 6 warning messages stop execution. Values from 1-6 are for warnings, 10-19 are for problems in COPT, 20-32 are for problems in OPT, values $\geq 40$ are caused by problems that probably are due to bugs in this plotting software that should be fixed.
Beginning in OPT(2), the user provides option specifications as described in Section B. 3
COPT [in] Character options, and data used by options in OPT, as described in Section B. 4
For simplest usage, set OPT(2) $=0$ and COPT $=$ ' Q '.

## B. 3 Numerical Option Descriptions

Options are specified by providing a sequence of codes starting in OPT(2), and by sequences of characters in $\operatorname{COPT}()$.
For options specified in $\operatorname{OPT}()$, each code is a whole number, followed by zero or more "arguments."

Arguments are numbers, which depending on the option, may be whole numbers. They may be data or indices into the array $\operatorname{COPT}()$ indicating the location of a character datum. Where we write (Argument $\mathrm{X}=\mathrm{n}$ ) below, n is the default value for X if the option is not selected.
"Whole numbers" in OPT() are determined by using the Fortran nint() intrinsic function, that is, the nearest whole number to $\operatorname{OPT}(\mathrm{j})$ is used if $\operatorname{OPT}(\mathrm{j})$ is expected to be a whole number.

If an option code is negative, say $\operatorname{OPT}(\mathrm{j})<0$, then OPT(j) is not processed, but the number of "arguments" used by option $|\operatorname{OPT}(\mathrm{j})|$ are skipped.

## Number Description

0 No more options. Option zero must be specified, and must be last in the list of options. If no other options are specified, the following defaults apply:

- Physical units are inches.
- One curve is plotted, using a solid line 0.5 points wide. Points are connected by a Bézier curve that is not closed.
- XMIN, XMAX, YMIN and YMAX are determined automatically.
- All four borders are drawn, with automatically determined and labeled "tick" marks on the bottom and left borders.
- The output is $\mathrm{AA}_{\mathrm{E}} \mathrm{X}$ in file splot.tex.

1 (Argument $N 1=0) N 1$ is a whole number in which the decimal digits specify options. Digits of N1 mean: $10^{0} 0=$ Finish the curve, and the plot. Physical units are in inches.
$1=$ Finish the curve, and the plot. Physical units are in millimeters. $1 \mathrm{in} .=25.4 \mathrm{~mm}$.
$2=$ Finish the curve, and the plot. Physical units are in points. $1 \mathrm{in} .=72.27 \mathrm{pt}$.
$3=$ Finish this mfpic group, but allow the plot to be continued on a subsequent call. Use this for multiple curves if you have capacity problems with Metafont. This option requires that in your $\mathrm{T}_{\mathrm{E}} \mathrm{X}$ or $\mathrm{IAT}_{\mathrm{E}} \mathrm{X}$ document the file generated by SPLOT be included with a statement of the form $\backslash$ hbox $\{\backslash$ input ... \}, where ... is the file generated by SPLOT and there is a space preceding the
closing "\}". In $\mathrm{IAT}_{\mathrm{E}} \mathrm{X}$ one can use mbox in place of hbox. (Units are needed only when plot finishes.)
$4=$ Finish the curve but allow the plot to be continued on a subsequent call.
$5=$ More data for the current curve may be provided on a subsequent call.
See special considerations in Section C.
$10^{1} 0=$ Interpolate between points using a Bézier curve; do not close the curve.
$1=$ Interpolate between points using a Bézier curve; close the curve with a Bézier curve.
$2=$ Interpolate between points using a Bézier curve; close the curve with a straight line.
$3=$ Connect points using straight lines; do not close the curve.
$4=$ Connect points using straight lines; close the curve with a straight line.
$5=$ Do not connect the points. This is frequently used with option 10 .
$10^{2}$ Specifies how X is used to determine the abscissa, $\xi$ of the point plotted, and how a border or axis with labels depending on X is labeled. When $10^{\xi}$ is output for a label, if the major ticks are 1 unit apart in $\xi$, then minor ticks (if any) will be spaced logarithmically.

Options for logarithmic or polar conversion apply to curves, and to options $14, ~ 15$, and 16 . Those for logarithmic conversions apply to options 19.21 Polar coordinates are not implemented in the current code.
In the case of polar coordinates, the points plotted are $(\mathrm{X} \cos \mathrm{Y}, \mathrm{X} \sin \mathrm{Y})$, and

- XMIN, XMAX, YMIN and YMAX are interpreted as $r_{\min }, r_{\max }, \theta_{\min }$, and $\theta_{\max }$, respectively.
- $r_{\min } \geq 0$ is required.
- Physical coordinates are Cartesian. The origin of the physical coordinate system coincides with the origin of the user (polar) coordinate system, and is within the figure.
- In a user Cartesian coordinate system derived from the polar coordinate system, $x_{\text {min }}$ is $-r_{\text {max }}$ if $\theta_{\text {min }} \leq 180^{\circ}+k \times$ $360^{\circ} \leq \theta_{\max }$ for some integer $k$, else it is
$\min \left(0, r_{\text {max }} \cos \theta_{\text {min }}, r_{\text {max }} \cos \theta_{\text {max }}\right) . \quad x_{\text {max }}$, $y_{\text {min }}$ and $y_{\text {max }}$ are defined similarly. Given a point $(r, \theta)$ in the user's polar coordinate system, in the physical Cartesian coordinate system, $\mathrm{X}_{\text {physical }}=\mathrm{XSIZE} \frac{r \cos \theta}{x_{\max }-x_{\text {min }}}$, and $\mathrm{Y}_{\text {physical }}=$ YSIZE $\frac{r \sin \theta}{y_{\max }-y_{\text {min }}}$.
- The border indices are $1 \Rightarrow \theta=\theta_{\min }, 2 \Rightarrow$ $r=r_{\min }, 3 \Rightarrow \theta=\theta_{\max }$ and $4 \Rightarrow r=r_{\max }$.
$10^{3}$ The preceding table applies with X replaced by Y and $\xi$ replaced by $\eta$ unless in polar coordinates. In the case of polar coordinates,

$10^{4}$ Let $x_{b}$ denote a vertical line drawn from border to border at the 0 point on the bottom border, if for this border XMIN $<0<$ XMAX. Similarly let $x_{t}$ be a vertical line at 0 as defined by the top border, $y_{\ell}$ a horizontal line relative to the 0 on the left border, and $y_{r}$ a horizontal line relative to the 0 on the right border. In all cases if the 0 line isn't strictly inside the borders, the line is not drawn.
$0=$ Draw $x_{b}$ and $y_{\ell}$.
$1=$ Do not draw any extra lines.
$2=$ Draw $x_{b}$ only.
$3=$ Draw $y_{\ell}$ only.
$4=$ Draw $x_{t}$ only.
$5=$ Draw $y_{r}$ only.

2 (Arguments $\mathrm{K} 2=\mathrm{NX}, \mathrm{L} 2=1$ ) L 2 sets of ordinates are provided in $\mathrm{Y} . \mathrm{K} 2$ is a whole number that gives NDIMY, the declared first dimension for $\mathrm{Y}(\mathrm{K} 2 \geq$ NX), and L2 is a whole number that gives NY, the number of sets of ordinates, i.e. the effective second dimension for $Y$. The total dimension for $Y$ must be $\geq$ NDIMY $\times$ NY. If a curve has been started but not yet finished, that is, SPLOT was most recently previously called with option 1, and with digit $10^{0}$ of $\mathrm{N} 1=5$, and NY is changed by specifying this option, an error message is produced. NY must not be greater than the parameter MAXNY in SPLOT, which is currently 50 .

3 (Argument $\mathrm{P} 3=50) \mathrm{S} 3$ specifies whether lines drawn are solid, dashed, or dotted, and the pen width for
solid or dashed lines. In the case of dashed lines one can indicate the length of the lines and the nominal space between them. In the case of dotted lines, one can specify the diameter of the dots and the space between them. Digits of 93 are used as follows:
$10^{0}$ Pen type.
$=0$ Solid lines. (The only other thing to specify for this case is line width in $10^{1: 2}$ below.)
$=1$ Dashed lines.
$=2$ Dotted lines.
$=3,4$ As for 1,2 , except units for the length of dashes or the diameter of the dots is in decipoints instead of in points. See $10^{3: 4}$ below.
$=5-8$ As for $1-4$, except units for the length of the spaces, see $10^{5}$ below, are in deci-points instead of in points.
$10^{1: 2}$ The width for solid or dashed lines in decipoints. A value of 0 gives the default value of 5 deci-points. Here are lines of widths 3,5, 7 and 10 deci-points: |||| .
$10^{3: 4}$ The length of the dashed lines or the diameter of the dots. Units are points or deci-points, depending on the value of the low order digit of P3.
$10^{5}$ The nominal space between the dashed lines or the dots. Units are points or deci-points, depending on the value of the low order digit of P3.

4 (Arguments $\sqrt{4}, 54, \mathrm{~T} 4=0) \mathrm{N} 4$ is a whole number in which every decimal digit $k$ for which $1 \leq k \leq 6$ stipulates that S 4 and T 4 specify characteristics for border $k$. Border indices are: $1 \Rightarrow$ bottom, $2 \Rightarrow$ left, $3 \Rightarrow$ top, $4 \Rightarrow$ right, $5 \Rightarrow$ X-axis if XMIN $<0<$ XMAX, $6 \Rightarrow$ Y-axis if YMIN $<0<$ YMAX.
$\$ 4$ is a whole number in which the decimal digits have the following meanings:

104: Gives the space in points to set aside for labels + outward pointing tick marks + border captions. If this is 0 , this space will be estimated.

The defaults for bottom and left borders are 6 , for top and right borders are 1 , and for axes, are 0 .

T 4 is a whole number in which decimal digits have the following meanings:
$10^{0: 1}$ The number of minor intervals within each major interval. If zero the value is determined automatically.
$10^{2}$ Defines how range on variable is expanded.
$0=$ Expand the range so that a major "tick" mark appears at automatically-determined ends of border $k$ if the major "tick" mark would be at zero, else expand the range to a minor "tick" mark.
$1=$ Expand the range so that a major or minor "tick" mark appears at automaticallydetermined ends of border $k$.
$2=$ Expand the range so that a major "tick" mark appears at automatically-determined ends of border $k$.
else Do not expand the range.
$10^{3:}$ If nonzero, this is the index in COPT of the same kind of text allowed after a textual option character of 1-6 as defined in Section B.4. If more than one border/axis is indicated, the caption pointed to will be applied to all of them. Thus it is best to use COPT options 1-6 as described in Section B. 4 below, unless this is being used for an extra data set, see Option 7 .

5 (Arguments $\mathrm{N} 5=123456, \mathrm{~A} 5=4.0 \mathrm{pt}, \mathrm{B} 5=3.0 \mathrm{pt}$ ) N 5 has the same meaning as $\mathrm{N} 4, \mathrm{~A} 5$ is the physical length of major "tick" marks along border $k$, and $\mid \mathrm{B} 5$ is the physical length of minor "tick" marks, both in points. "Tick" marks of positive length are directed inward, while "tick" marks of negative length are directed outward. If the physical length is $>$ than the length of the plot ( $10^{5}$ should do this), the line is drawn the full length of the plot.

6 (Arguments $\sqrt{6}, \times \sqrt{6}, \mathrm{D}$ ) $\sqrt{6}$ has the same meaning as $\sqrt{4}$. If $\mathrm{D} 6>0$ then major "tick" marks will be drawn at all positions for which $[\mathrm{XY}] \mathrm{MIN} \leq \mathrm{X} 6+$ $k \times \mathrm{D} 6 \leq[\mathrm{XY}] \mathrm{MAX}(k$ integer $)$. If $\mathrm{D} 6>0$ this option supersedes digits $10^{0: 1}$ of T4.

7 (Argument $\mathrm{B} 7, \mathrm{~S} 7,17, \mathrm{P} 7$, U7) One may specify multiple data sets, and thus plot different curves on the same figure with different scalings and with a specified alignment. One should not specify this option without having already provided all of the data and options that reference a prior data set.

B7 This gives the index of the border used for annotations and labels for the new data set. See option 4 for definitions of borders 1-4. Values of 5 and 6 refer to the current data set for X and Y, and can be used to set values for P 7 and U 7 on the initial data set. If B 7 indexes a border already in use by another data set, that border with associated tick marks and labels (if any) is output immediately, and the working area of the plot is reduced by moving the new location of this border towards the center of the plot.
S 7 As for S 4 for the new border, $1 \leq \mathrm{B}[7 \leq 4$.
T 7 As for T 4 for the new border, $1 \leq \mathrm{B} 7 \leq 4$.
P7 A distance in the same physical units as XSIZE and YSIZE from the left or bottom end of the border. See 47 below. If this is less than 0 , there will be no effort to align the points for the different data sets.
U7 A value in user coordinates associated with this border. Data will be plotted in such a way that a data point with a coordinate with this value will be plotted at the distance from the left or bottom end of the border indicated by P 7 . This provides a means to align plots for the different data sets.

8 (Arguments $\mathrm{A} 8=0, \mathrm{~B} 8=0$ ) If $\mathrm{A} 8<\mathrm{B} 8, \mathrm{~A} 8(\mathrm{~B} 8)$ gives the smallest (largest) value of X for the current dataset. Values outside this range will be clipped, i.e. will not appear in the plot. If all values are in this range, the plotting region is chosen as if these extreme values occurred.

9 (Arguments $\mathrm{A} 9=0, \mathrm{~B} 9=0$ ) Similar to option 8 , but for Y instead of X.

10 (Argument $\sqrt{10} \ldots$...) Plot symbols as specified by 10 at the current data points. In addition data points are connected or not as set by digit $10^{1}$ of $\sqrt[1]{1}$.
N10<0 means another N 10 follows immediately, and $\mathrm{N} 10=0$ draws no symbols. If several curves are being plotted (see option 22), the first uses the first $\mid \mathbb{N} 10$, etc. If NY specifies more curves than the number of symbols specified, the specification for the last 10 $\geq 0$ is re-used.
$\mid \mathrm{N} 10$ is a whole number in which decimal digits have the following meanings:
$10^{0} \neq 1$ Plot symbols with vertices evenly spaced on a circle.
$10^{0}$ The number of vertices, $v . v=0$ describes a circle, in which case digits $10^{1: 2}$ are ignored.
$10^{1}$ The number of vertices, $s$ to "skip" when drawing edges, except that $s \geq v$ means "draw lines from the center to the vertices." To include all the vertices when $s<v$, $\operatorname{gcd}(v, s+1)$ polygons are drawn, each time starting one vertex counterclockwise from the previous starting vertex.
$10^{2}$ Rotation, $n$. The first vertex is at an angle of $n \frac{45^{\circ}}{v}$ counterclockwise from the $x$-axis direction.
$10^{3}$ The width of line to use, $w$, in deci-points. If $w=0$ then $w=3$ is used. If $w=9$, the symbol is filled.
$10^{4: 5}$ The diameter of the circle in points. If 0,6 is used.
$10^{6:}$ If this is not 0 , the symbol is opaque i.e. pixels inside the symbol are cleared before drawing the symbol.
Possible values for $\mid \mathrm{N} 10$ include

## B. 4 Textual Option Descriptions

Data at the beginning of $\operatorname{COPT}()$ consists of strings headed by a single character that identifies the kind of string that follows. After the last of such strings, COPT() may contain character strings pointed to by various options. Strings pointed to must begin with "[", " $\{$ ", or "(".
Options specified entirely in $\operatorname{COPT}()$ consist of a single letter or number code followed by text associated with the option. All letters used in options may be in either upper or lower case. Option codes may be preceded by blanks. Where we write "[]", "()", or "\{\}" (no text inside), the following is to be understood.
[] Always optional. Contains two or four letters between the brackets that define how an item is centered relative to some nominal position. The first is either $\mathrm{t}, \mathrm{c}$, or b for top, center (vertically), and bottom. The second letter is either l, c, or r, for left, center (horizontally), and right. One may follow the second letter with an s which indicates the text is "stacked" (vertically), and a following letter that must be 1 , $c$, or $r$, to indicate how the text is justified horizontally inside the stack. Inside a stack, text enclosed in balanced " $\{\ldots\}$ " or " $\$ . . \$$ " is kept on a single line.
() Always optional. Contains information between the parentheses on formatting numbers and on the size of text (in points). Items can appear in any order,
with no intervening spaces. Letters can be in either upper or lower case, and \# is used to denote an integer which if not present causes the nominal value to be used. The following can be specified.
. Always print a decimal point.
F\# Font size in points. (The only case that makes sense if "()" is being used in connection with text output. Thus "(F12)" would be used to indicate text or numbers that are in 12 point.) The default is 9 point.
D\# Number of significant digits that must be printed.
A\# Number of digits that are required after the decimal point.
B\# Number of digits that are required before the decimal point,
X\# $0<\#<10$, bias for selecting the exponent notation. If \# is zero, it is replaced by 5 . where IO is the unit number, automatically selected, associated with this file, and NY is 1 or, if set, the value of K2 in option 2. If NX is sufficently large data is read to the end of the file.

M\{Raw plot output $\}$ The raw plot output is sent directly to the plot device driver, except that $\backslash$ serves as an escape character (i.e. $\backslash \mathrm{x}$ for any " x " is replaced by x ).
"1-6" []()\{Border/axis_caption\} Specification for a caption to be printed on a border/axis, where a single digit from 1 to 6 is used as in Option 4. A c for vertical positioning on a vertical line or for horizontal positioning on a horizontal line causes the text to be centered with respect to that direction outside any labels that may be present. Defaults for "[]" are [bc], [cl], [tc], [cr], [cr] and [tc] for the bottom, left, top, right, x -axis, and y -axis respectively.

The \# is not used in this case. When using $\mathrm{IAT}_{\mathrm{E}} \mathrm{X}$ the default " $\backslash$ small" is not generated in this case if the first character following the $\{$ is a $\backslash$.

Thus "1\{Label bottom border\}" will place text centered below the bottom border with a baseline at the edge of the figure. And the default for the $x$-axis centers text vertically just past the right end of the axis. If one were to use [bc] on the top border, the text would have a baseline at the top of the figure. If defaults are used, a caption for a vertical line that requires more than two character lengths unstacked than it would require if stacked, will be stacked by adding sc to the positioning information.

## B. 5 Incorporating the Output Into a $\mathrm{T}_{\mathrm{E}} \mathrm{X}$ or IATEX Document

SPLOT generates output intended to be processed by the mfpic package of $\mathrm{T}_{\mathrm{E}} \mathrm{X}$ or $\mathrm{LA}_{\mathrm{E}} \mathrm{X}$ macros. See Section D below for more details. Using $\mathrm{LT}_{\mathrm{E}} \mathrm{X}$ or PDFEATEX one can generate either ".dvi" files or ".pdf" files. We describe both approaches, but recommend using PDFLATEX as it gives documents that are easier to share and it is easier to get set up. Also for many of our plots we had to use our own version of gftopk as the standard version does not set aside enough memory for the character sizes that are generated for the plots.
The general form of a $\mathrm{AT}_{\mathrm{E}} \mathrm{X}$ document that incorporates plots generated by SPLOT is:

## B. 6 Modifications for Double Precision

For double precision usage, change the REAL type statement to DOUBLE PRECISION, and change the subroutine name to DPLOT. The default file name for output, used if option F in COPT() is not selected, is dplot.tex.

## C. Examples and Remarks

The example given is that used to generate the plot in Chapter 2.2.

If one produces a curve or set of related curves by setting the $10^{0}$ digit of $N 1=5$ and calling SPLOT several times to supply data values, the value of NY must be the same on every call that contributes to the construction of the curve(s).
If one produces a plot by making several calls to SPLOT, using digit $10^{0}$ of N 1 to indicate that the plot is or is not to be finished on the current call, the following considerations are important:

- The specifications whether "tick" marks are linearly or logarithmically spaced are those in effect when the plot is finished.
- The specifications whether to plot data as given, or to plot $\log _{10} X$ or $\log _{10} Y$, are remembered from one invocation of SPLOT to the next, but, if changed, are separately observed.
- The specification to use a polar coordinate system is the one in effect when the plot is finished.
- The units and values of XSIZE and YSIZE are those in effect when the plot is finished.

All options are reset to their default values when SPLOT is first invoked, or when invoked after finishing a plot. When SPLOT is invoked after having been invoked with instructions not to finish the plot, all optional settings retain their values from the previous invocation until changed by option selections in the current invocation, except that digit $10^{0}$ of N 1 is reset to zero, and L 27 is reset to zero before the option selections are processed.
We also give a simple example here of taking output in a file to make a plot, and give scripts illustrating how to
get the plots. Program plotf.f takes output from a file and calls dplot. Scripts plotpdf and plotdvi shows how to to do the whole job where the program tedxrk8 is the program used to generate the results and the $\mathrm{A}_{\mathrm{E}} \mathrm{X}$ file is stepsel.tex.

## D. Functional Description

## D. 1 Sequence of Events

Each time SPLOT is invoked, the character options in COPT are processed, then the numeric options in OPT are processed, then the data are processed. Most numeric options, and all data, are stored on a scratch file, and processed when digit $10^{0}$ of $\mathrm{N} \leq 2$.
Numeric options are processed in the order they appear, and the setting of one may affect the interpretation of another. When data are processed, the most recently
previous setting of an option that affects the data or their interpretation is effective, even if that setting occurred during a previous invocation of SPLOT for the same plot.
The effects of options or fields of options on subsequent options, and data, are summarized in the table at the beginning of Section B.3. The column labelled "Scratch File" indicates whether the option, or some of its fields, are put onto the scratch file, along with the data.
The plot border, axes, tick marks, labels, and captions are output first. Then data on the scratch file is output in the following order. First all data for a given mfpic group is output before that for another. Within each such group, curves are output, then single symbols, then rectangles and ellipses, and finally text annotations.

## D. 2 Context of Usage - Interaction with $\mathrm{IT}_{\mathrm{E}} \mathrm{X}$ and $\mathrm{T}_{\mathrm{E}} \mathrm{X}$

Plots are rendered into marks on the page by converting them to characters of a font. The mfpic package instructs $\mathrm{T}_{\mathrm{E}} \mathrm{X}$ or $\mathrm{IA}_{\mathrm{E}} \mathrm{X}$ to put commands to produce the font into the file <fontname>.mf specified by the $\backslash o p e n g r a p h s f i l e ~ c o m m a n d ~(s e e ~ S e c t i o n ~ B .5) . ~$.

The document is thus produced by invoking the $\mathrm{T}_{\mathrm{E}} \mathrm{X}$ or IATEX program to produce the file $<$ fontname $>$.mf, processing $<$ fontname $>$.mf by the mf program, and then invoking $\mathrm{T}_{\mathrm{E}} \mathrm{X}$ or $\mathrm{LA}_{\mathrm{E}} \mathrm{X}$ again to account for the "font metrics" and to incorporate the font "characters" that implement the plots.
After processing by the mf program, it may also be necessary to use the gftopk program, depending on how the .dvi file is ultimately converted to a format for a specific printer.
Finally, the document is converted from "device independent" (.dvi) form to a form usable by a specific printer by a dvi program specific to that printer.
Consult documentation specific to your system for details of usage of $\mathrm{T}_{\mathrm{E}} \mathrm{X}, \mathrm{AR}_{\mathrm{E}} \mathrm{X}$, mf, gftopk and dvi programs.
A version of the mfpic macros accompanies the libraries.
Some implementations of gftopk have insufficient capacity to process output from mf resulting from using mfpic. A version of gftopk that has more capacity accompanies the libraries. You will need a C compiler to compile it for your system.

## E. Error Procedures and Restrictions

Although this software has been used to produce the wide variety of plots in the MATH77 documentation, time constraints have meant that a good number of the options have not been checked. It is expected that there
will be bugs in some of these unchecked options. These will be fixed as they arise. Any errors due to a bug should be obvious from an examination of the plot if the bug allows the code to get this far. The C versions of this code have been checked only on the simple demonstration drivers and thus are even more likely to suffer from bugs.

An error message is produced if $\mathrm{OPT}(1)$ is returned non-zero. All errors are processed by the error message processor described in Chapter 19.3. If the error messages provided do not clear up the problem, looking at $<$ plotname $>$.tex may clarify the problem for you.

## F. Supporting Information

The source language is ANSI Fortran 77.
